The Oxford House Program provides individuals with a substance-free living environment entirely supported by the members of the home. Financial responsibilities are handled by the residents in each house, making a cooperative measure necessary for the success of the residents. Home tasks and activities are led by an officer of each house; officers are elected by other residents of the home and serve a sixmonth term before another election is held. Relapse is a large concern within the Oxford House system and is taken very seriously. If at any point the majority of the residents feel as if officers or other residents have relapsed, they will be expelled from the residence.
