SERVED YOUR TIME? THEN IT'S YOUR TIME TO VOTE!

UNLOCK YOUR VOTE! VOICE YOUR OPINION IN TEXAS' 2022 ELECTIONS!

ARE YOU "OFF PAPER"? YOU CAN REGISTER AND VOTE!

Have you completed your sentence? You have the right to register and vote in Texas if you are not currently in prison, or on felony probation or parole.

REMEMBER: To vote, you must be at least 18 years of age on Election Day, a U.S. Citizen, and a resident of the county where you registered to vote, and you must not have been declared mentally disabled by a court.

IMPORTANT DATES:

Submit your voter registration at least **30 days** before the election. Upcoming registration and election deadlines are as follows:

- ▶ **Last Day to Register to Vote: January 31, 2022**
- ▶ **Early Voting Period: February 14-February 25, 2022**
- ▶ **Election Day: March 1, 2022**

HOW TO REGISTER



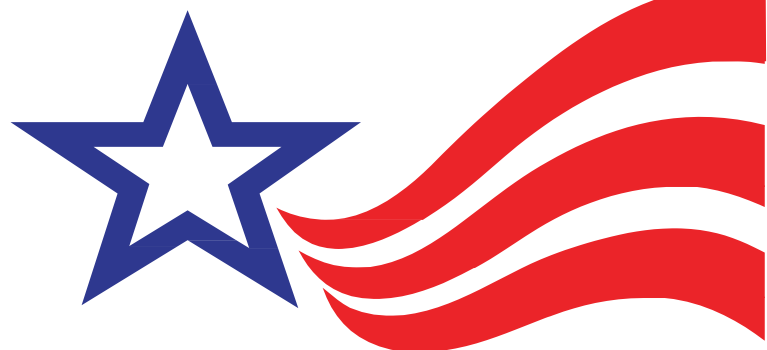
ONLINE ACCESS:

If you have access to a computer and printer, visit www.votetexas.gov.

- ➡ **Click REGISTER TO VOTE**
(the first tab on the blue panel at the top of the page)
- ➡ **Click "WHERE TO GET AN APPLICATION"**
(the second blue link under "Register to Vote" on the left side)
- ➡ **Click "VOTER REGISTRATION APPLICATION ONLINE"**
(a blue link under the headline "Get an Informal Online Application")

The first step of the application asks you if you are a United States citizen. **If you are a citizen, click "yes"** and you will move on to the full voter registration application. **Be sure to complete all questions.** Once you have completed all the questions on the online form, **press the SUBMIT button** located towards the bottom of the screen. After you press submit, you will be brought to another webpage to print your application. **Click PRINT** to print your online application.

MAKE SURE TO SIGN AND DATE the bottom of the application at the X. Place the application in a stamped envelope and mail it to your county voter registrar. A list of county registrars and their addresses can be found at www.sos.state.tx.us/elections/voter/votregduties.shtml.



PAPER APPLICATION:

No computer? No problem! Registration applications are available at various post offices, libraries, and many stores like HEB.

Just request a registration form, complete the form with a pen, and make sure to write in your city and zip code in the partially-addressed mail-to section for the Registrar of Voters. This form is postage paid, so you won't need a stamp to mail it.

QUESTIONS AND ANSWERS!

➡ **I was registered to vote before my conviction. Do I need to re-register?**

Yes. If you were registered to vote before you were convicted of a felony, your registration was terminated, and you will need to fill out a new registration form.

➡ **Are you experiencing homelessness or staying at a shelter? You can still register to vote!**

You can often register to vote using a shelter address, like Salvation Army. Just remember, if you use their address, your voter certificate will be mailed there. Check with a staff person at your shelter for a registration form and ask to use the shelter address.

➡ **I sent in my registration application. Now what?**

After you mail your registration application, it will be processed, and you should receive your **"Voter Registration Certificate"** in the mail at the address you wrote on your application **within 30 days**. Once you receive your certificate, **sign it**, and make sure to **bring it on Election Day**.

➡ **I received a "Response to Notice of Examination" letter in the mail. What should I do?**

Sometimes the Secretary of State sends a letter to confirm that you are "off paper" and eligible to vote. If you receive this letter, fill it out, and immediately **mail it back to your county voter registrar**. **A list of county registrars and their addresses can be found at www.sos.state.tx.us/elections/voter/votregduties.shtml.**

If you have been convicted of a felony, you will need to fill out a section that looks like this:

- _____ I have been convicted of a felony, however:
- _____ I have been pardoned.
- _____ I have reached the completion of my sentence (including probation or parole).
- _____ My case is currently under direct appeal.

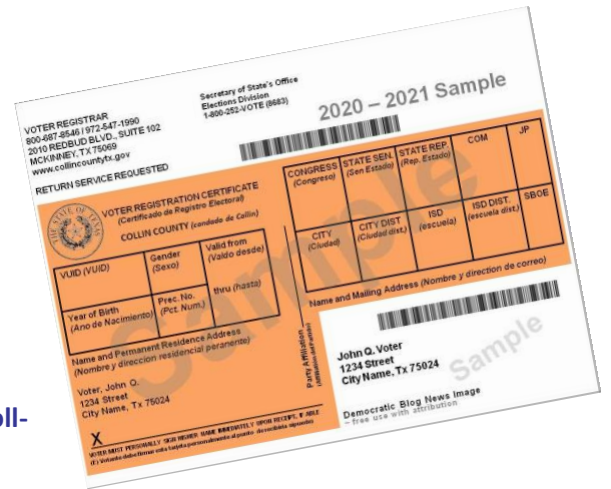

After you check the appropriate line above, make sure to **sign and date your response**. If you signed your name, then you do not need to fill out the bottom half of the form.

⇒ I didn't receive my Voter Registration Certificate. What should I do?

If you didn't receive your certificate within 45 days, you should call **your local Tax Assessor-Collector or your local Elections Administrator** so that they can find out why the card's mailing may have been delayed. The contact information for each county's voter registration official is available on the **Texas Secretary of State website** at www.sos.state.tx.us/elections/voter/votregduties.shtml. If you do not have access to a computer, you may call the Texas Secretary of State to request the contact information of your county voter registration office **toll-free at 1-800-252-VOTE (8683)**.



⇒ I'm registered! Now, how do I vote?

Find Your Polling Place. Your voter registration certificate or card will have the number of the precinct in which you'll vote on Election Day. (A precinct is a geographic area in your county.) **Check your local news on the Saturday before the election** for the address of the polling place for your precinct. You can also check this site for more information: www.votetexas.gov/voting/where.html. **On Election Day**, arrive at the precinct **between 7 a.m. and 7 p.m.** to vote.

If you can't find your polling location, call your county registrar for help. You can find yours at www.sos.state.tx.us/elections/voter/votregduties.shtml.

When you enter your polling place, show your voter registration card and a valid I.D. to the election official. Depending on the type of voting machine they use, they'll either provide you with a paper ballot, number, or ballot activator card that enables you to vote on the machine. If you have questions about using the machine or filling out a ballot, just ask the poll worker for help. They are there to make sure your vote is counted!

Valid I.D. options include:

- ▶ Texas driver license issued by the Texas Department of Public Safety (DPS)
- ▶ Texas personal identification card issued by DPS
- ▶ Texas election identification certificate issued by DPS
- ▶ Texas handgun license issued by DPS
- ▶ United States military identification card containing your photograph
- ▶ United States citizenship certificate containing your photograph
- ▶ United States passport



With the exception of the U.S. citizenship certificate, the identification must be current or have expired no more than 4 years before being presented for voter qualification at the polling place. (Source: www.votetexas.gov/register-to-vote/need-id.html)

BEAT THE LINES! VOTE EARLY.

After you are registered to vote, **you have the option of voting early in person.** Voting early is quick and easy. **Call your county voter registrar** (see website: www.sos.state.tx.us/elections/voter/votregduties.shtml) to find an early voting location near you! Make sure to **bring your voter registration certificate and I.D.** (see I.D. options at left).

- ▶ **Election Day is March 1, 2022, with Early Voting from February 14-February 25, 2022**

⇒ I cannot obtain one of the seven forms of approved photo I.D. Can I still vote?

If you have a reasonable impediment or difficulty obtaining such identification, you may present a supporting form of identification and complete a Reasonable Impediment Declaration. The Reasonable Impediment Declaration form may be found at www.sos.texas.gov/elections/forms/pol-sub/reasonable-impediment-declaration.pdf. It must be completed both by the voter and by the election official.

Supporting forms of ID include: Valid voter registration certificate, certified birth certificate (must be an original), and a copy of or original of the following: current utility bill, bank statement, government check, paycheck, government document with your name and address (original required if it contains photograph). **If you have a disability, you may also apply with the county voter registrar for a permanent exemption.**

⇒ My name is not on the list of registered voters. Can I still vote?

Yes. If your name is **not on the list** of registered voters at your polling place, ask to **fill out a Provisional Ballot**.

⇒ I went to vote, but I forgot my Voter Registration Certification and I.D. Can I still vote?

Yes. If you forgot your Voter Registration Certification *and* I.D., ask to **fill out a Provisional Ballot**.

⇒ I am confined in jail either serving a misdemeanor conviction or awaiting trial. Can I still vote?

Yes. If you are in jail awaiting trial or you have a misdemeanor conviction, and you are not on probation or parole, and **you meet all other voting eligibility requirements, you can vote!** The best way to make sure your vote is counted is to **vote early by mail**. If you are already a registered voter, you (or a loved one) may print an application for Ballot by Mail from the Secretary of State website at www.sos.state.tx.us/elections/voter/reqabbm.shtml.

If you do not have access to a printer, you can visit that same website to **request that an application for Ballot by Mail** be sent to you. If you do not have access to a computer at all, you may write a letter **requesting an application for a Ballot by Mail, and requesting the address of your county's Early Voting Clerk** from:

Your letter requesting the application for Ballot by Mail and the address for the early voting clerk could begin:

Dear [Name of County] Early Voting Clerk:

I am writing to request a Ballot by Mail. I would like to vote in the General Election [or other type of election] on November 8, 2022 [or other date of election]. My voter registration address is [include address]. I am currently confined in jail [or am outside my county] and request that a ballot be mailed to me at [address of jail; or you can request that a ballot be sent to a relative—include their relationship to you].

Note: you must make separate requests for a Ballot by Mail for each election in which you want to vote.

Your application must be received no earlier than the 60th day and no later than the 7th day before Election Day. If the 7th is a weekend or holiday, the deadline is the first preceding business day. Completed Ballots by Mail must be returned to the County Clerk's office by mail or by contract carrier by 7:00pm on Election Day.



⇒ If I still have questions about the voter registration or voting process, what can I do?
